Upon signing this membership agreement (the "Membership Agreement"), Member authorizes the disclosure and release of information to the Club for investigating qualifications for membership.

In accepting the risk of injury, Member agrees to indemnify and hold harmless Woodbridge Golf Club and respective directors, officers, members, shareholders, employees, and agents from any and all loss, cost, claims, injury, damages or liability sustained or incurred by Member, Member's guests and Member's family resulting from or arising out of any conduct or event connected with membership in the Club and use of any of the Club's facilities.
